3 PUBLIC FORUM / DEPUTATIONS

- Kellie Jordan and Callie Manser from the Keith Kindergarten & Childcare Centre addressed Council regarding a future Keith Kindergarten & Childcare project:
 - The Keith Kindergarten and Childcare Governing Council have identified a need for a redevelopment of the existing building as more floor space is required. Currently have a waiting list as there is not enough space to accommodate all the children that require the service. There is also a real challenge in accommodating new children in foster care, a state government requirement.
 - Would like the building to be a modern, functional space and it needs to be fit for purpose.
 - The service currently caters to a very wide area of people and would also be a drawcard for those seeking employment in the region.
 - First step of the project would be to conduct a feasibility study and want to engage an architect who specialises in the area of kindergarten/child care building. Have received quotes for the study which approximate \$13,500.
 - Letting Council know of what the group's intentions are. Would be seeking financial assistance for the cost of the study in the way of a community grant, and some project management expertise.

- Sam Densley and Matt Fiebig from the Apex Group in Keith addressed Council foreshadowing a community grant re: liberty swing:
 - Have raised over \$20,000 for the purchase of a liberty swing to be installed in Don Moseley Park, Keith. The swing allows those using wheelchairs to enjoy the joy of swinging.
 - The Club has arranged for a builder who will provide in kind support to prepare the site, but a specialist is required to install the rubber base for the project. The Club is seeking a community grant to cover the cost of the installation of the rubber which is approximately \$9,500.
